#### Tinker's Creek Watershed Partners receives multiple Grants.

TWINSBURG, Ohio, March 27, 2012 – Tinker's Creek Watershed Partners (TCWP), a non-profit organization working to restore and protect the Cuyahoga River's largest tributary, announces its receipt of a three-year, \$32,000 per year operating grant from the Ohio Department of Natural Resources (ODNR), Division of Soil and Water. The grant was officially awarded and took effect on February 28, 2012.

The grant will be used to fund the full-time position of the organization's watershed coordinator, Babette Oestreicher, who was appointed in October 2011. In this role and in accordance with grant stipulations, Oestreicher will implement the State of Ohio-endorsed Tinker's Creek Watershed Action Plan. Additionally, the grant will support Oestreicher's outreach efforts within the 24 watershed communities that encompass Tinker's Creek to develop and execute educational programs, fundraising initiatives and other awareness campaigns.

"Tinker's Creek Watershed Partners is very lucky to have the support of ODNR with this grant. It will allow us to enrich our current relationships with regional and state-wide agencies, both public and private, to bring Tinkers Creek back into attainment," said Justin Czekaj, president of the TCWP board of directors.

Tinker's Creek Watershed Partners was additionally awarded \$3,594 from the Burning River Foundation Fresh Ideas for Freshwater grant program to implement a sustainable lawn care demonstration project at the Hudson Montessori School in Hudson, Ohio. The funding, which was awarded to TCWP in January of this year, will be directed toward removal of invasive species, planting of native vegetation and installation of two rain barrels and two composting bins on the school grounds. As part of the project, the school will also reduce overall use of chemicals to treat its lawn and gardens. Project efforts will be incorporated into the 6<sup>th</sup>grade student curriculum and completed by July 2012.

"The receipt of this grant is a significant benefit to both TCWP and to the Hudson Montessori School," said Czekaj. "The grant will allow us to implement the educational outreach goals of the Watershed Action Plan. This funding also helps us produce a compelling demonstration project that exemplifies the type of projects that can be implemented at additional schools in the watershed."
