Fall is for Planting

September to November is one of the best times of year to plant many trees, shrubs, and perennial species. The cooler temperatures and increased autumn rains help the plants establish stronger root systems before winter. Plants need six weeks to establish healthy root systems before the ground freezes.

Invasive Species Alert



Be on the lookout for the Spotted Lantern Fly. This pest is native to SE Asia and has been documented in Cuyahoga County. It is extremely invasive and will damage to both crops and native tree species. If spotted call the Ohio Department of Agriculture immediately at 614-728-6400.

Restoration Projects



Owen Brown Street Stream Restoration

TCWP has been awarded a Section 319 with the Ohio and US EPA to restore >1,800 linear feet of stream in Hudson! The City of Hudson had provided generous match for this project.

Design on this project has been completed, and we anticipate construction beginning this fall once permits are approved.

HUB District Riparian Enhancement

Warrensville Heights has been awarded a \$34,000+ Clean Ohio grant from the Ohio Public Works Commission with matching funds of \$11,000+ from the City. Funds will be used to enhance and permanently protect 5.6 acres of riparian habitat and wetlands along Bear Creek, a major tributary to Tinker's Creek.
